That Change Order No. 1, dated January 1, 1980, heretofore filed with the City Clerk of said City as Document No. RR-251754, issued in connection with the contract between The City of San Diego and Metro-Young Construction Company for improvements to SOUTH CHOLLAS CREEK CHANNEL BETWEEN I-805 AND IMPERIAL AVENUE, said contract having been filed in the office of the City Clerk as Document No. 250692, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$21,593.00, and an extension of time of 10 working days extending the completion time to 100 days, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$28,575.00 from Water Utility Fund 41502 to Fund No. 18513, Element 85.56 (South Chollas Creek Channel), solely and exclusively for the above project.
