BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Fifteen (15) year Lease Agreement with RICHARD GLEASON for the operation and management of the Mission Bay Sailing Center, located at Santa Clara Point, Mission Bay Park, for a rental of 10% of all gross income versus a guaranteed annual minimum of \$7,500, whichever is greater, under the terms and conditions set forth in that Agreement on file in the office of the City Clerk as Document No. RR-251760.
