BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$652,154.00 from Capital Outlay Fund 30245 and \$7,416.00 from Federal Revenue Sharing Fund, CIP 31-018 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
