

That the Personnel Director be, and he is hereby authorized and empowered to execute, for and on behalf of said City, agreements with the San Diego Unified School District, the Sweetwater Union High School District and the Poway Unified School District to allow them to conduct career enrichment training programs for the 1980 Summer Youth Employment Program (SYEP) under Title IV of the Comprehensive Employment and Training Act (CETA) of 1978, under the terms and conditions set forth in the agreements on file in the office of the City Clerk as Document Nos. RR-251791-1, RR-251791-2, RR-251791-3, respectively.

BE IT FURTHER RESOLVED, that the expenditure of \$186,671.00 be hereby authorized out of CETA IV REGY SYEP FY 80 funds, solely and exclusively, for the above stated purposes.
