That the Mayor and City Clerk of the City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, copy of which is on file in the office of the City Clerk as Document No. R-251801 granting to the SAN DIEGO METROPOLITAN TRANSIT DEVELOPMENT BOARD all that portion of Lots A-79, A-80 and A-81, Little Landers Subdivision of San Ysidro, as more particularly described in the deed.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a right-of-way contract in connection with the sale of the property, a copy of which contract is on file in the office of the City Clerk as Document No. R-251801-2

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver the documents and a certified copy of this resolution to the Property Department for further handling.
