BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That a state of emergency and urgent need exists with respect to the immediate restoration of San Diego Mission Road across the San Diego River.
- 2. That the public interest or necessity demands the immediate expenditure of public funds to safeguard life, health or property.
- 3. That the specifications are approved and the competitive bids provisions of Section 94 of the City Charter are waived to allow the Purchasing Agent to seek bids without advertising for formal bids for the purpose of the emergency reconstruction of San Diego Mission Road across the San Diego River.
- 4. That the City Manager is authorized to execute a contract with the lowest responsible and responsive bidder.
- 5. That an expenditure not to exceed \$156,000 from Storm Damage Fund is authorized for purposes of executing this contract.
