

RESOLUTION No. R-251843 (R-80-2140)


Adopted on MAY 19 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street, Slope and Drainage Easement Deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of January 11, 1980, conveying to the City a permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across all that portion of the West Half of the Southeast Quarter of the Northwest Quarter of Section 18, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named EL CAMINO REAL.

That the City Clerk is hereby authorized and directed to deliver the deed, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
