

RESOLUTION No. R-251847 (R-80-2120)


Adopted on MAY 19 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of April 1, 1980, conveying to the City a permanent easement and right-of-way for a public street and incidents thereto over, under, upon, along and across the southerly 2 feet of Lot 438 of Sunshine Gardens, Map No. 1804, as more particularly described in that deed, be, and the same is hereby dedicated as and for a public street, and the same is hereby named MARKET STREET.

That the City Clerk is hereby authorized and directed to cause that deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
