(3) A First Amendment to Agreement Between The City of San Diego and San Diego National League Baseball Club, Inc. for Partial Use and Occupancy of the San Diego Stadium, under the terms and conditions set forth in the first amendment to agreement on file in the office of the City Clerk as Document No. RR-251848-3.
