

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with THE COUNTY OF SAN DIEGO, whereby the County shall prepare an Environmental Assessment of the Penasquitos Canyon Regional Park development and the City shall pay one-half the cost of the assessment, not to exceed \$17,500, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. RR- 251850.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$17,500 from Environmental Growth Fund (No. 10505) Open Space Maintenance Program (No. 210) for the assessment is hereby authorized and approved.
