

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That Resolution No. 251466, adopted March 24, 1980,
is hereby amended to read as follows:

That the City Manager be and he is hereby authorized and
empowered to execute, for and on behalf of said City, an
agreement with INNIS-TENNEBAUM, ARCHITECTS, INC. for an amount
not to exceed \$48,000 to provide a program including cost
estimating, scheduling, plans, specifications, inspections
and related services for the Civic Theatre - Rehabilitation,
under the terms and conditions set forth in the agreement on
file in the office of the City Clerk as Document No. RR-251466.


BE IT FURTHER RESOLVED, that the expenditure of \$41,000
and \$7,000, for a total not to exceed \$48,000, is hereby
authorized from Public Works Employment Act Title II and
Transient Occupancy Tax Fund 223, respectively, solely and
exclusively for the professional architectural services and
related costs.

2. That the expenditure of \$235,500 that was trans-
ferred into C.I.P. 34-036(80) from Unemployment Insurance
Reserve Fund 60-060, and \$115,150 remaining in C.I.P. 34-060(80)
is hereby authorized, solely and exclusively for the purposes
of awarding construction contracts.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be
and he is hereby authorized, upon the advice from the adminis-
tering department, to transfer excess budgeted funds, if any, to
the appropriate reserves.

3. That the City Manager be and he is hereby authorized to execute, for and on behalf of said City, construction contracts with the lowest responsible bidders.
