

RESOLUTION NO. R- 251878Adopted on MAY 27 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Michael D. Eacobellis	General Services	\$1,000	Mr. Eacobellis is an Equipment Mechanic in the Equipment Division. He suggested that one inch spacers be added to air intake ducting on refuse vehicles. This reduces tubing damage and prevents several major engine overhauls annually. Estimated savings are \$13,254.
Peter C. Solomonsen	Police	\$ 500	Mr. Solomonsen is a Police Officer. He suggested that background investigations be dictated rather than hand written. Estimated annual savings are \$50,054 officers' time. This is a partial award pending a final 12-month review.
Donald W. Pyke	Utilities	\$ 380	Mr. Pyke is an Associate Administrative Analyst in the Services Division. Approximately one year ago he earned a partial award of \$350 for his suggestion to convert Quarterly Management Report periods to coincide with Auditor reporting periods. One year's experience has shown a total savings of \$7,287. This is the remainder of his award.
Betty M. Conley	Library	\$ 225	Ms. Conley was a Junior Typist at the time of her suggestion. Approximately one year ago she earned a partial award of \$220 for her suggestion to use a rubber stamp to record information on Library patrons' files. One year's experience has shown a total savings of \$4,465. This is the remainder of her award.
