

RESOLUTION NO. R-251879Adopted on MAY 27 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
James K. McCormick	General Services	\$ 170	Mr. McCormick is a Building Manager in the Buildings Division. He suggested that the Police Department specify the office location as the delivery site for equipment purchases. This is expected to save \$3,416 annually in moving services. This is a partial award pending a final 12-month review.
Michael D. Eacobellis Earnest D. Warren	General Services	\$ 150	Mr. Eacobellis and Mr. Warren are Equipment Mechanics in the Equipment Division. They suggested that refuse vehicle exhaust be converted to move with engine torque. This reduces maintenance costs \$1,510 annually.
Ronald F. Miller	Building Inspection	\$ 140	Mr. Miller is a Senior Building Inspector. He suggested that Form IN-13 be simplified to reduce the time it takes to complete. Estimated first year's savings are \$2,788. This is a partial award pending a final 12-month review.
Beverly J. Andresen Eustis Nikas	General Services	\$ 135	Ms. Andresen is a Supervising Sanitation Investigator, and Mr. Nikas is a Sanitation Supervisor in the Solid Waste Division. One year ago they earned a partial award of \$140 for their suggestion to coat the bottom surfaces of galvanized trash cans with tar. One year's experience has shown a total savings of \$2,766. This is the remainder of their award.
