

RESOLUTION NO. R-251880Adopted on MAY 27 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Richard A. Creighton	General Services	\$ 120	Mr. Creighton is an Equipment Mechanic in the Equipment Division. He suggested that the hitch on beach screen tractors be shortened. This saves \$1,188 annually in repairs.
Frances C. Wyborney	Library	\$ 120	Ms. Wyborney is an Intermediate Typist. She suggested that Overdue Book Notices be revised to reduce handling. This is expected to save \$2,429 annually. This is a partial award pending a final 12-month review.
William A. Nelson	Police	\$ 110	Mr. Nelson is a Police Officer. He suggested that filmstrips be purchased to replace classroom kits. First year's savings are expected to be \$2,249. This is a partial award pending a final 12-month review.
Lorin D. Mico	Park & Recreation	\$ 105	Mr. Mico is a Lifeguard Lieutenant in the Aquatics Division. Approximately one year ago he earned a \$10 partial award with his suggestion to replace wooden lifeguard stands with stands made of galvanized pipe. One year's experience has shown a total savings of \$1,128. This is the remainder of his award.
