

RESOLUTION NO. R-251881Adopted on MAY 27 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Willie D. White	General Services	\$ 95	Mr. White works in the Solid Waste Division. One year ago he earned a partial award of \$95 for his suggestion to replace the bottom of galvanized litter container liners with a disc. One year's experience has shown a total savings of \$1,924. This is the remainder of his award.
Rose L. Leary	City Clerk	\$ 95	Ms. Leary is an Administrative Aide II. She suggested that eleven media bundles of docket back-up material be eliminated. Since these materials were not used, savings are expected to be \$1,896 annually. This is a partial award pending a final 12-month review.
Eustis Nikas	General Services	\$ 90	Mr. Nikas is a Sanitation Supervisor in the Solid Waste Division. One year ago he earned a \$95 partial award for his suggestion to replace only the swinging door to Hanson litter can lids. One year's experience has shown a total savings of \$1,855. This is the remainder of his award.
Robert E. Minter	General Services	\$ 85	Mr. Minter is an Electrician in the Buildings Division. One year ago he earned a partial award of \$80 for his suggestion to add switches to fourteen rooms in COB. One year's experience has shown a total energy savings of \$1,630. This is the remainder of his award.
David R. Jacks	General Services	\$ 80	Mr. Jacks is an Equipment Mechanic Apprentice in the Equipment Division. He suggested that grease fittings be installed on City pick-up trucks. This is expected to save \$1,602 annually in maintenance costs. This is a partial award pending a final 12-month review.
