

RESOLUTION NO. R-251882Adopted on MAY 27 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
John P. Casey Thomas H. Herzberger	Building Inspection	\$ 75	Mr. Casey and Mr. Herzberger are Building Technicians. They suggested that a plan submission checklist be used. This is expected to save \$1,500 annually in the verification of information. This is a partial award pending a final 12-month review.
Joseph A. Rametta	Engineering & Development	\$ 70	Mr. Rametta is an Engineering Trainee. He suggested that a terminal board be installed in traffic counters to prevent machine loss during maintenance. This is expected to save \$705 annually.
Patricia J. Di Giacomo	Treasurer	\$ 70	Ms. Di Giacomo is a Senior Typist. She suggested that referral cards be copied rather than retyping them. This is expected to save \$1,398 annually in processing costs. This is a partial award pending a final 12-month review.
Ascencion Reyes	Property	\$ 60	Mr. Reyes is a Gardener at the Stadium. He suggested that a permanent form be developed to construct the pitcher's mound. This is expected to save \$600 annually in the time it takes to construct the mound.
George R. Ikeda	General Services	\$ 50	Mr. Ikeda is a Carpenter in the Buildings Division. He suggested that restroom partition specifications be revised to accept only those made formica over wood. This is expected to reduce maintenance by \$522 annually.
