

RESOLUTION NO. R-251883Adopted on MAY 27 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Walter K. Faust	Fire	\$ 50	Mr. Faust is a Fire Fighter. He suggested that flashlight lenses be stored at Fire Stations to reduce the number of flashlights replaced. This is expected to save \$480 annually in parts.
John A. Barton Dick Wintworth	Property Engineering & Development	\$ 50	Mr. Barton is a Greens-keeper Supervisor at the Stadium, and Mr. Wintworth is a Survey Party Chief. They suggested that permanent reference markers be installed at the Stadium for field conversion from baseball to football. Estimated annual savings are \$493.
Frank Alesi	General Services	\$ 50	Mr. Alesi is an Equipment Mechanic in the Equipment Division. He fabricated a safety holder for the steam cleaner. This was considered to be a significant safety improvement.
Donald R. Jordan	Park & Recreation	\$ 45	Mr. Jordan is an Equipment Operator I in the Park Division. One year ago he earned a \$95 partial award for his suggestion to use identification stickers on Park trash cans. One year's experience has shown a total savings of \$1,424. This is the remainder of his award.
Alison M. Gonzales	Planning	\$ 40	Ms. Gonzales is a Senior Stenographer. She suggested that clerical time used for Community Planners' meetings be eliminated. This is expected to save \$405 annually. This is a partial award pending a final 12-month review.
