

RESOLUTION NO. R-251884Adopted on MAY 27 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Thomas G. Simonds	Police	\$ 35	Mr. Simonds is a Police Officer. He suggested that a form be developed to use with vehicle impounds. This form is expected to streamline processing and save \$370 annually.
Eleanor M. Wells	Auditor	\$ 30	Ms. Wells is an Account Clerk. She suggested that a semi-annual report for long range deposits be eliminated. This saves an estimated \$304 annually in processing costs.
Myrna F. Choate	Risk Management	\$ 30	Ms. Choate is an Administrative Aide II. She suggested that Suggestion Awards Program record keeping forms be preprinted with standard information. This saves an estimated \$101 annually in processing costs.
Virginia R. Edwards	City Attorney	\$ 30	Ms. Edwards is a Senior Clerk. She suggested that the Employee Suggestion Form include instructions to the suggester. This has been done. Although savings could not be calculated, this is expected to provide evaluators with more concise information.
Ray Haskell	General Services	\$ 25	Mr. Haskell is a Carpenter in the Buildings Division. He suggested that the brickwork at the entrance of COB be refinished to reduce tripping hazards and improve appearance. Savings were impossible to calculate. This was considered to be a significant safety improvement.
