

RESOLUTION NO. R-251886

Adopted on MAY 27 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Herb M. Yaklin	Park & Recreation	\$ 20	Mr. Yaklin is a Utility Worker I in the Park Division. He suggested an improvement in the manner in which suggesters who not earned suggestion awards are notified. Although no savings could be shown, this was considered to be a significant public relations improvement.
Gloria J. Butler	Financial Management	\$ 10	Ms. Butler is a Programmed Typewriter Operator. One year ago she earned a \$10 award for her suggestion to use both sides of the paper when typing drafts. The price of paper has escalated drastically in the past year, and an additional award was warranted.
Michael D. Eacobellis	General Services	\$ 10	Mr. Eacobellis is an Equipment Mechanic in the Equipment Division. He suggested that the springs and u-bolts in lifeguard vehicles be galvanized to reduce wear. Savings will be calculated at the end of a year. This is a partial award pending a final 12-month review.
William A. Nelson	Police	\$ 10	Mr. Nelson is a Police Officer. He suggested that a stamp be used to make School Safety Patrol School store cards. This saves \$100 annually in printing costs.
Eileen J. Reynolds	Library	\$ 10	Ms. Reynolds is an Intermediate Typist. She suggested that Form LI-1350 be revised. This increases the utility of the form and reduces printing costs by \$30 annually.
