Jonathan T. Harker	Building Inspection	\$ 10	Mr. Harker is an Intermediate Typist. He suggested that a noise control permit notification form be printed rather than copied. Although savings could not be estimated, this was considered to be a significant operational improvement.
Dave Spisak	Police	\$ 10	Mr. Spisak is a Lieutenant. He suggested that a suggestion award display be posted in each Police report room. Although savings could not be calculated, this was considered to be a significant operational improvement.
Linda A. Menefee	Personnel	\$ 10	Ms. Menefee is a Junior Typist in the Clerical Pool. She suggested that rings be used for suggestion awards files to decrease the amount of time needed to access files. This saves an estimated \$25 annually.
