BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over, under, upon and across Lot 5, together with an access easement in Lot 5 with the right of ingress and egress of emergency vehicles, all as shown on this map within this subdivision.


