BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of WILLIAM M. and MARY R. ARNOLD, husband and wife, executed in favor of The City of San Diego, bearing date of August 21, 1979, conveying to the City a permanent easement and rights-of-way for a public street and any incidental uses thereto, over, under, upon, along and across all that portion of Lot 91 of Las Alturas Villa Sites, as more particularly described in that deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named ALTA VISTA AVENUE.

That the City Clerk is hereby authorized and directed to cause that deed, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
