BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, First Amendments to Agreements with GEOCON, INC., LEIGHTON AND ASSOCIATES and WOODWARD-CLYDE CONSULTANTS for geotechnical consultant services from July 1, 1979 to June 30, 1980 for a sum not to exceed \$25,000 for each consultant firm, under the terms and conditions set forth in the first amendments to agreements on file in the office of the City Clerk as Documents No. RR-251908-1, No. RR-251908-2 and No. RR-251908-3 respectively.

BE IT FURTHER RESOLVED, that the expenditure of \$75,000 is hereby authorized from Deposit Trust-Subdivision Fund for the sole and exclusive purpose of providing funds for the consultant services.
