BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized to make an application for and acceptance of a grant from the California State Library to fully fund a study of ways that the City and County of San Diego can improve library service within existing spending restraints; said application is on file in the office of the City Clerk as Document No. RR-251911-1

That the City Librarian is hereby designated as Fiscal Agent for the grant and is authorized to expend the grant funds.

That the City Manager is hereby authorized to enter into a consultant agreement with ROBERT H. ROHLF ASSOCIATES for the above study, contingent upon receipt of grant funding; said agreement is on file in the office of the City Clerk as Document No. RR-251911-2.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to establish a fund for the monies, to receive these monies, and to expend these monies in conformance with the above agreement.
