BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the transfer of \$732,000 from T.O.T. New Convention Facility Fund No. 10225 to the Redevelopment Agency for the purpose of providing funds for the schematic drawing phase of the architectural services agreement for the convention center facility to be located within the Columbia Redevelopment Project is hereby authorized and approved.

BE IT FURTHER RESOLVED, that this transfer from the City to the Redevelopment Agency is an advance to be repaid to the City from future tax increments, lease revenue or other Project income in accordance with Redevelopment Agency Resolution No. 412.
