BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the low bid of HAM BROTHERS CONSTRUCTION, INCORPORATED, a corporation are hereby accepted; and the City Manager is hereby authorized to execute a contract for CONSTRUCTION OF INTERSTATE 8 RELOCATION in the amount of \$363,556.

That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$39,859.00 within the Water Revenue Fund (41502) from Water Unallocated Reserve (70679) to Water Construction Outlay (70592), C.I.P. 73-024 (Annual Allocation Freeway Relocation).

That the expenditure of \$39,859 from the Water Revenue Fund #41502, of The City of San Diego, be hereby authorized, solely and exclusively, to supplement Resolution No. 251247, adopted on February 25, 1980.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized to enter into a Revised Utilities Agreement No. 24668 with the State Department of Transportation, said agreement is on file in the office of the City Clerk as Document No. RR-251922.
