WHEREAS, The City of San Diego is the owner of a portion of Silver Terrace, Ruby Street and Linda Vista Road Closed; and

WHEREAS, the City desires to negotiate the sale of said land to MISSION VIEWS DEVELOPMENT, under the provisions of Section 22.0907 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City, as determined by independent fee appraisal, is the sum of SEVENTY-FOUR THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$74,750); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property described in that Grant Deed on file in the office of the City Clerk as Document No. R-251944, be, and the same is hereby authorized to be sold by negotiation for the sum of SEVENTY-FOUR THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$74,750) to MISSION VIEWS DEVELOPMENT.
 - 2. That the Mayor and City Clerk of said City be, and

they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, copy of which is on file in the office of the City Clerk as Document No. R-251944, granting to MISSION VIEWS DEVELOPMENT all that portion of Silver Terrace, Ruby Street and Linda Vista Road Closed, as more particularly described in said deed.

- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
