

RESOLUTION No. R-251954

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager, be and he is hereby authorized to establish City-wide tennis fees through the implementation of a permit system which shall be effective on all City-owned tennis courts except the Pacific Beach and La Jolla Tennis Clubs.

The permit system fee schedule shall be as follows:

Senior Citizen (60+)	\$ 27.50	\$ 40

\* A \$1.00 service charge for the cost of issuing an identification card is recommended by staff.

All tennis courts will have signs posted listing a tennis fee information phone number. The Pacific Beach and La Jolla Clubs will have "Open to the Public" signs posted.

BE IT FURTHER RESOLVED, that the Auditor is hereby directed to implement accounting procedures which will identify all revenues and all expenditures dealing with the City tennis program, effective July 1, 1980.
