BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Agreement with the SAN DIEGO HOUSING COMMISSION to transfer the responsibility of the Housing Rehabilitation Program for San Ysidro and Golden Hill, as of August, 1979, from the City to the Housing Commission, under the terms and conditions set forth in that Agreement on file in the office of the City Clerk as Document No. RR-251955.

BE IT FURTHER RESOLVED, that the transfer of \$131,821 from Fund 18514, Dept. 7330, Org. 7331, Housing Rehab., San Ysidro-City, to Fund 18514, Dept. 7330, Org. 7338, Housing Rehab., San Ysidro-Housing Commission, and \$561,972 from Fund 18514, Dept. 7330, Org. 7332, Housing Rehab., Golden Hill-City, to Fund 18514, Dept. 7330, Org. 7339, Housing Rehab., Golden Hill-Housing Commission, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the expenditure of such funds, totaling \$693,793, in accordance with the Agreement, work program and budget, is hereby authorized and approved.
