BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Agreement with the SAN DIEGO HOUSING COMMISSION to administer the Housing Rehabilitation Program in the Housing Improvement Area #1 (Southcrest-Oceanview), under the terms and conditions set forth in that Agreement on file in the office of the City Clerk as Document No. RR-251956.

BE IT FURTHER RESOLVED, that the allocation and expenditure of not to exceed \$3,070,913 from 5th Year (1979) CDBG Fund 18515, Dept. 5910, Org. 5911, subject to the environmental clearance and release of funds by the Department of Housing and Urban Development, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that this authorization supercedes authorization granted by Council Resolution No. R-250266, adopted on September 19, 1979.
