APPROVING MAP OF DALEY-BOOTH BUSINESS PARK

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by TAT L. WAI, a Registered Civil Engineer, entitled "DALEY-BOOTH BUSINESS PARK Being a subdivision of a portion of Lots 1 through 6, Block 28 of Rosedale, according to Map thereof No. 826, filed in the office of the County Recorder of San Diego County, January 21, 1897, and a portion of Olive Avenue, as vacated and closed to public use, all being in the City of San Diego, County of San Diego, State of California.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Viewridge Avenue and a portion of Viewridge Court for public purposes, and said street and portion of a street are hereby declared to be a public street and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities and slopes, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street and portion of a street are accepted on behalf of the public as heretofore stated; and that those certain easements for sewer and drainage facilities and slopes, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
