WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, OLIVE AVENUE and a portion of VIEWRIDGE AVENUE has been superceded by a new street, VIEWRIDGE AVENUE, being dedicated with the acceptance of the final map of the subdivision to be known as DALEY-BOOTH BUSINESS PARK; and

WHEREAS, those properties adjoining OLIVE AVENUE and a portion of VIEWRIDGE AVENUE to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the subdivision to be known as DALEY-BOOTH BUSINESS PARK; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That OLIVE AVENUE and a portion of VIEWRIDGE AVENUE, as more particularly shown on Drawing No. 18765-D on file in the office of the City Clerk as Document No. RR-251973, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
