

RESOLUTION NO. R- 251974 (R.80.2157)

WHEREAS, with the approval of the final map of DALEY-
BOOTH BUSINESS PARK subdivision, the City shall receive ease-
ment interests which allow the quitclaim of existing sewer
and drain easements within the subdivision; and

as follows:

That the Mayor and the City Clerk are hereby authorized

Diego, a quitclaim deed, a copy of which is on file in the office
of the City Clerk as Document No. RR- 251974, quitclaiming
to DALEY CORPORATION, a California corporation, all the City's
right, title and interest in the sewer and drain easements, as
more particularly described in said quitclaim deed.
