WHEREAS, the Sister Cities International meets annually in member cities across the nation; and

WHEREAS, San Diego bid for and was awarded the honor of hosting the 1980 Sister Cities International Conference during the period August 13 through August 17, 1980; and

WHEREAS, the City Council authorized the sum of \$8,500 from Transient Occupancy Tax Funds to help underwrite said conference; and

WHEREAS, the San Diego-Yokohama Sister City Society has agreed to serve as the central coordinating and host agency for said conference; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO-YOKOHAMA SISTER CITY SOCIETY, a California charitable corporation, to promote and host the 1980 Sister Cities International Conference during the month of August, 1980, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-251984.
