A RESOLUTION OF THE CITY COUNCIL AMENDING THE 9 1980 CAPITAL IMPROVEMENT PROGRAM FOR FISCAL YEAR 1979-80, BY AMENDING DOCUMENT NO. 766809, AS AMENDED, BY CANCELLING C.I.P. PROJECTS NO. 23-822, ENTITLED "SOUTH MISSION BEACH PIER REMOVAL" AND 34-032, ENTITLED "SAN DIEGO STADIUM-AUTOMATIC WATER SPRINKLING SYSTEM"; REDUCING THE APPROPRIATION FOR C.I.P. PROJECTS NO. 36-032, ENTITLED "EASTERN AREA POLICE STATION" BY \$355,777 AND 36-030, ENTITLED "SOUTHERN AREA POLICE STATION" BY \$353,845; TRANSFERRING THE SUM OF \$709,622 TO THE CAPITAL OUTLAY RESERVE (90-245).

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Section 2, subsection 26 of the annual appropriation ordinance, the Capital Improvements Program for fiscal year 1980 as contained in Document No. 766809, as amended, be and the same is hereby further amended as follows:

- That C.I.P. Projects No. 23-822, entitled "South Mission Beach Pier Removal" (in the amount of \$35,000) and 34-032, entitled "San Diego Stadium-Automatic Water Sprinkling System" (in the amount of \$27,000) be and the same are hereby cancelled.
- 2. That the appropriations for C.I.P. Projects No. 36-032, entitled "Eastern Area Police Station" and No. 36-030, entitled "Southern Area Police Station" be and the same are hereby reduced by the amounts of \$355,777 and \$353,845 respectively.
- That the sum of \$709,622, resultant from Section 2 above be and the same is hereby transferred to the Capital Outlay Reserve (90-245).
