That the bid of TAYLOR BUS SERVICE is hereby accepted on the condition that Taylor Bus Service will provide to the City a certificate of insurance in the amount of \$5,000,000 with The City of San Diego named as an additional insured and the further condition that all buses used on this contract with The City of San Diego will be inspected and approved by the California Highway Patrol prior to their use.

BE IT FURTHER RESOLVED, that the City Manager is authorized to execute a contract for the rental of bus and van service as may be required for a period of eight (8) weeks beginning June 16, 1980 through August 8, 1980 for a total cost of \$46,839.00, terms net with an option to renew the contract for an additional one (1) to two (2) weeks.


