

RESOLUTION NO. R- 252003

(R. 80-2282)

WHEREAS, existing personal income tax law allows a deduction for taxes paid on the sale of gasoline, diesel fuel, and other fuels; and

WHEREAS, Senate Bill 1911, authored by Senator Petris, would eliminate such tax deductions and allow a tax credit up to specified amounts, in computing taxable income for transit commute passes and the cost of vanpool and buspool service; and

WHEREAS, it is anticipated that this bill would encourage commuters to use vanpools, buspools and public transit; and

WHEREAS, this bill would provide a tax credit to any employer providing vanpool service to employees and to others;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby expresses and urges support of Senate Bill 1911, as amended on April 21, 1980.
