APPROVING MAP OF MIRA MESA GRACE CHAPEL SUBDIVISION JUN 16 1980

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM J. RICHARD, a Licensed Land Surveyor, entitled "MIRA MESA GRACE CHAPEL Being a subdivision of a portion of the east half of the northwest quarter of Section 31, Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, together with a portion of Westmore Road, as dedicated to public use" is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Westmore Road for public purposes, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.


