RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO, CALIFORNIA, PROPOSING TO MAKE  
CHANGES IN THE STANDLEY PARK ASSESSMENT  
DISTRICT PROCEEDINGS AS ORDERED PURSUANT  
TO RESOLUTION NO. 212224.

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council heretofore adopted Resolution No. 212224 and subsequently ordered work and improvements pursuant thereto; and

WHEREAS, Section 7 of said Resolution states that if, after completion of the improvement and payment of all claims from the improvement fund any surplus over \$1,000 shall be applied as a credit upon the assessment and any supplemental assessment, in the manner provided in Sections 10427.1 and 10427.2, Streets and Highways Code; and

WHEREAS, after completion of the improvement and payment of all claims from the improvement fund there remains a surplus of \$244,567; and

WHEREAS, the Council desires to use \$24,884 of said surplus for professional services of LYKOS AND GOLDHAMMER, ARCHITECTS AND ENGINEERS, for the design of additional improvements at Standley Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The Council hereby proposes and declares its intention to order the following change to be made:

A. That the sum of \$24,884 be authorized to be paid from the Standley Park Improvement Fund for professional services of LYKOS, GOLDHAMMER, ARCHITECTS AND ENGINEERS, for the design of additional improvements at Standley Park.

Section 2. NOTICE IS HEREBY GIVEN that August 12, 1980, 1980, at the hour of 2:00 p.m. in the Council Chambers of the Council at the City Administration Building, 202 C Street in said City, are the day, hour, and place when and where any interested person having any objection to the change proposed herein may appear before the Council and show cause why such change should not be ordered. Written objections to the proposed change may be filed with the City Clerk by any interested person at any time not later than the time set for the hearing.

Section 3. The City Clerk is further directed to publish this resolution in the Daily Transcript, a newspaper of general circulation published and circulated in said City, said publication to be given at the time and in the form and manner provided by law.

Section 4.
