A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 766809, AS AMENDED, BY ADDING PROJECT NO. 46-059, ENTITLED "POINT LOMA SEWAGE TREATMENT PLANT PARTS STOREROOM BUILDING," TO THE FISCAL YEAR 1979-80 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING AND DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER FUNDS IN THE SUM OF \$400,000 FOR THE ABOVE PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That pursuant to Section 2, subsection 26 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 777809, as amended, be and the same is hereby further amended by adding C.I.P. Project No. 46-059, Point Loma Sewage Treatment Plant Parts Storeroom Building, to the fiscal year 1979-80 Program.
- 2. That the Auditor and Comptroller be and he is hereby authorized to transfer within Sewer Revenue Fund 41506 from the Unallocated Reserve (70697) to Wastewater Quality Construction (70292) the sum of \$363,500, and to Engineering Design (70642) the sum of \$36,500 for said Project No. 46-059.
