The expenditure of an amount not to exceed \$22,000 under terms and conditions set forth in the September 7, 1977 agreement between City and Auditors and the Auditors' letter of June 2, 1980, respectively on file in the office of the City Clerk as Documents No. 76111 and No. 74-252042 is also hereby authorized.
