needed for State highway purposes; and

WHEREAS, the City Council has found and determined that
it is desirable and in the public interest that said highway
right-of-way be relinquished to the City of San Diego for
use as a City street.

NOW, THEREFORE, BE IT RESOLVED, that the City Council
of The City of San Diego herewith agrees to assume jurisdic-
tion and accept full control and maintenance of the relin-
quishment within the City of San Diego.
