The City Council of The City of San Diego hereby consents to a joint public hearing with the Redevelopment Agency of The City of San Diego on the proposed First Amendment to the Redevelopment Plan for the Columbia Redevelopment Project, a copy of which First Amendment is on file in the office of the City Clerk as Document No. 252051, and hereby authorizes the City Clerk, in cooperation with the Executive Director of the Agency, to establish the date, time and place therefor.
- 2. The City Clerk of The City of San Diego shall, in cooperation with the Executive Director of the Agency, publish and mail notice of public hearing on the proposed First Amendment to the Redevelopment Plan, in the manner, and with other documents as required and established by law.
