A RESOLUTION PROVIDING FOR COST RECOVERY FOR
PLANNING AND DEVELOPMENT SERVICES.

WHEREAS, the City Council has directed that City
services be cost recoverable whenever possible; and

WHEREAS, The City of San Diego's Progress Guide and
General Plan and Municipal Code require that development
occur in accordance with adopted plans; and


WHEREAS, owners/developers are currently paying actual
processing costs for other City services related to land
development; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an initial deposit of \$25,000 be established to
recover actual City costs related to the processing of
development feasibility studies or community and precise
plans, including implementation plans, in the Planned
Urbanizing Areas of the City, and that the Planning Director
adjust this deposit as necessary to assure complete recovery
of all related City costs.
