BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with CONROCK CO., a Delaware corporation, for the realignment of Black Mountain Road, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RC-252060-1.

2. That the plans and specifications for the realignment of Black Mountain Road, on file in the office of the City Clerk as Document No. A-00109, be and they are hereby approved.

3. That the City Auditor & Comptroller is hereby authorized to transfer within Fund 30219 an amount not to exceed \$397,000 from CIP 52-203.1 to CIP 54-102.


4. That the expenditure of not to exceed \$17,800 from Fund 30245 (CIP 54-102) and \$471,300 from Fund 30219 (CIP 54-102) is hereby authorized for the purposes of executing this agreement and related costs, and the City Auditor & Comptroller is hereby authorized, upon advice from the Administering Department, to transfer excess budgeted funds, if any, to the appropriate reserves.

5. That the expenditure of not to exceed \$3,700 from Fund 30219 (CIP 54-102) is hereby authorized for the purposes

of acquiring necessary right-of-way and easements in Lot 6 of
Sacher-Miramar Industrial Tract, Unit No. 1, Map No. 7770, for
the realignment of Black Mountain Road.
