- 4. That the expenditure of not to exceed \$17,800 from Fund 30245 (CIP 54-102) and \$471,300 from Fund 30219 (CIP 54-102) is hereby authorized for the purposes of executing this agreement and related costs, and the City Auditor & Comptroller is hereby authorized, upon advice from the Administering Department, to transfer excess budgeted funds, if any, to the appropriate reserves.
- 5. That the expenditure of not to exceed \$3,700 from Fund 30219 (CIP 54-102) is hereby authorized for the purposes

of acquiring necessary right-of-way and easements in Lot 6 of Sacher-Miramar Industrial Tract, Unit No. 1, Map No. 7770, for the realignment of Black Mountain Road.
