

BE IT RESOLVED, by the Council of The City of San Diego as follows:

The City Manager is hereby authorized and directed to execute, for and on behalf of said City, an agreement with LUSK/MIRA MESA, a limited partnership, for City participation in the construction of a traffic signal system, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-252085.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$27,685.00 from Capital Outlay Fund 30245, CIP 62-150, Navajo Road concrete median barrier, to CIP 58-001, New Developments, and to transfer the sum of \$17,537.00 from Gas Tax Reserve, CIP-90-220, to CIP 58-001, New Developments, to provide for reimbursement by the City in an amount not to exceed the sum of \$74,600.00 from Capital Outlay Fund 30245, CIP 58-001, and in an amount not to exceed the sum of \$17,537.00 from Gas Tax Fund 30219, solely and exclusively for the purpose of providing funds for this project.
