BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of LUSK/MIRA MESA, a limited partnership, executed in favor of The City of San Diego, bearing date of April 30, 1979, conveying to said City the permanent easement and right-of-way to construct, reconstruct, maintain, operate and repair a public street, including any and all appurtenances thereto, together with the right of ingress and egress over, under, along and across all that portion of Section 4, Township 15 South, Range 3 West, San Bernadino Meridian, as more particularly described in that deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MIRA MESA BOULEVARD.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
