That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in The City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of the City shall cause to be

published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
