BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of SOUTHEASTERN CALIFORNIA ASSOCIATION OF SEVENTH DAY ADVENTISTS, a corporation, executed in favor of The City of San Diego, bearing date of November 9, 1979, conveying to said City an easement for public street purposes over, along and across that portion of Pueblo Lot 1219 of Pueblo Lands of San Diego, as more particularly described in that deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named HATHAWAY STREET.

That the City Clerk is hereby authorized and directed to cause that deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
